Revenue from sales is recorded at 1,568.05 million Baht, 7.99% up from the year earlier.

Net Income:

Year 2012, gross profit is 164.38 million Baht = 11.32% on sales

Year 2013, gross profit is 203.80 million Baht = 13% on sales, profit amount is up 23.98% from the year earlier.

Net Profit is 48.03 million Baht, down 18.73% from the year earlier. Due to currency exchange, weak Thai Baht in 4th quarter of this year, resulted by politics and QE policy.
